Conducted three library clerk interviews and hired two - Clover Wade and Charlotte Landreth to work weekends and to fill in if needed during the week. They started training the first week of April. Emily Stone started on March 1 as the Youth Services Coordinator. Held a staff meeting the first week of April.
